The improvements on the property will be located and encroachments onto or from the subject property will be determined. **This survey can be used by the property owner for the construction of a fence or other improvements.** The survey will meet "Minimum Standards for Property Boundary Surveys"

___ **ALTA/ACSM (American Land Title Association/American Congress on Surveying and Mapping) LAND TITLE SURVEY:** This is the most comprehensive type of improvement location. It covers all the aspects of the boundary survey and location and identification for any additional evidence of possession or use, which could be adverse to the interests of the purchaser. **This type of survey is normally only performed on commercial property because of the expense involved.**
